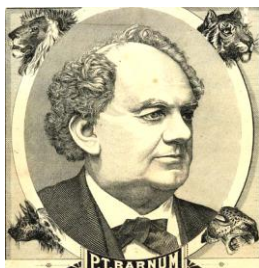

## PHOTOGRAPHIC REPRODUCTION POLICY

Please read this policy before completing the Image Use Authorization Agreement.

THE BARNUM MUSEUM is pleased to provide image services to individuals, institutions and commercial users. *Please note:* You may order and purchase images for personal use simply by completing the Photographic Services Order form, however if the purchased images are to be reproduced, published, or broadcast in any way, you must also complete the Image Use Authorization Agreement (IUAA), and pay the appropriate Photographic and Filming Usage Fees. This policy is subject to change without notice; the policy in effect at the time of order acceptance will govern.

**ORDERS & PAYMENT** – All orders for photographic services must be in writing on a Photographic Services Order Form. **Orders must be prepaid.** Make checks or money orders payable to The Barnum Museum Foundation, Inc. in U.S. currency only. They should be mailed to The Barnum Museum, 820 Main Street, Bridgeport, CT 06604. If a credit card purchase is necessary, please call the Museum's Business Manager during normal business hours at (203) 331-1104 ext. 100. Currently the Museum can accept Visa, Mastercard, and Discover cards.

**CREDITS, RIGHTS, PUBLICATION** – All photographic materials furnished to the customer retain their origin and must be credited to The Barnum Museum. No reproduction, use, publication or broadcast of any Barnum Museum image may occur without express written permission. Customers requiring such use authorization will complete and submit the IUAA with their order, at which time the Usage Fee will be determined. Only The Barnum Museum's IUAA will be used to grant rights. Provision of one or more reproduction formats is for the use specified and does not authorize future reproduction. The Usage Fee is in addition to the cost of purchasing images.

**OWNERSHIP**– All images, whether electronic files, negatives, transparencies or prints, shall remain the property of The Barnum Museum. If the requested image(s) is to be used on a website, it must be watermarked with The Barnum Museum's name to discourage unauthorized image capture and re-use.

**QUALITY** – The Barnum Museum strives to provide high quality images, and a number of our most popular items have been photographed professionally. However there are many items in our collection that will require photography or scanning in order to provide image files to customers. We strive to do fine quality in-house work to save the cost to you, but if you require exceptional quality for publication or film production purposes, please let us know so that we can discuss arranging to have a professional come in to photograph the item(s).

**Permissions for reproduction are granted subject to the following:**

1. Credit lines must accompany all materials and use the proper name of the institution: The Barnum Museum, Bridgeport, Connecticut. If information about the object or document is supplied by the Museum for inclusion in a caption or text, the substantive information may not be altered. When appropriate, the photographer/artist/maker's name will be supplied and should be included.
2. Reproduction restrictions: The Barnum Museum images may not be reproduced without specific written permission from the Museum. Permission may be obtained by completing an Image Use Authorization Agreement (IUAA). Images shall not be used to show or imply The Barnum Museum's endorsement of any commercial product or enterprise, or to indicate that the Museum concurs with opinions expressed in or confirms the accuracy of any accompanying text.
3. Copyright restrictions. Permission is granted only to the extent of The Barnum Museum's ownership of the rights relating to the request. Certain works may be protected by copyright, trademark, or related interests not owned by the Museum. The responsibility for ascertaining whether any such rights exist and for obtaining all necessary permissions remains with the applicant. In the case of works by living American artists, written permission must be obtained by the applicant from the artist before any reproduction is published.
4. The Barnum Museum reserves the right to inspect and approve color proofs before publication.
5. Any permission granted by The Barnum Museum shall be for the purpose as stated in the application. The image shall not be used for any other purpose, including publicity controlled by other sources (e.g., news media) without contacting the Museum for permission.
6. Permission is granted for non-exclusive, one-time, one-edition, English language use within the body of the publication or for one-time use in producing a television program, video tape, motion picture film or film strip, or website. You may choose single format use or multiple format use; in the case of the latter, all uses must directly relate to the approved project. Non-editorial use (e.g., book covers, book jackets, album covers, calendars, posters, or other commercial applications) requires special permission. The re-use of images, and the use of images in additional formats not originally requested, are subject to additional fees.
7. Details taken from images provided *may be used only with special permission* and must be indicated as such in the credit line. Superimposing images or text onto photographs is discouraged. The Barnum Museum reserves the right to inspect such sketches and layouts prior to granting permission for reproduction.
8. Immediately upon publication, two copies of the work will be furnished to The Barnum Museum at no cost to the Museum. If used in a website, color print outs are requested of all web pages depicting, describing, or linked to the image(s).
